

Approvals / Listings for Cadco Convection Ovens:

Our convection ovens are manufactured to Cadco Ltd. specifications by UNOX S.p.A. / S.r.I., Italy.

All have NSF, and UL through either CSA Standards or through MET:

1) **SAFETY:** All units are approved to the **Commercial UL Standard** for use without a mechanical ventilation system **IF** local codes permit.

The "MET" mark on our current data ovens data labels refers to the MET Product Safety Listing. (The MET Certification Directory web address is:

*Ventilation guidelines for current Cadco Convection Ovens:

Under local state or health codes, (i.e., California Department of Health & Safety,) our type convection ovens can *often* be used without a mechanical ventilation requirement under the following general conditions:

- 1) Maximum operating temperatures without mechanical ventilation shall be approximately 450 degrees F.
- **2)** Only breads, rolls, pastries, other baked goods and pizza may be prepared in the oven without mechanical ventilation.
 - No meats or poultry may be cooked in the oven without mechanical ventilation.
- **3)** The unit is operated in a well-ventilated area approved for food preparation.
- **4)** The unit will be installed, serviced and maintained according to manufacturer's specifications.

(***NOTE: California now requires an application and application fee to be considered for a waiver from hood requirements for any cooking appliance***)
